1. DESCRIPTION

ROBERTS® 2980 is a contract-grade adhesive formulated for the installation of most types of carpet and felt-backed sheet vinyl. Developed to have a longer open time for the optimal positioning of felt-backed vinyl flooring while it also develops tack for the installation of rigid-backed carpets.

1/8" x 1/8" x 1/16" (3 mm x 3 mm x 1.5 mm) Flat-Top V Notch

Flooring (porous substrate): Carpet Backings: (Woven & Polypropylene)

Coverage: $90-110 \; ft^2/per \; gallon \; (8.3-10.2 \; m^2/per \; 3.78 \; L)$

1/16" x 1/16" x 3/32" (1.5 mm x 1.5 mm x 2.3 mm) U Notch

Flooring (porous substrate): Felt-Backed Sheet Vinyl Coverage: 160-180 ft²/per gallon (14.8-16.7 m²/per 3.78 L)

1/16" x 1/16" x 1/16" (1.5 mm x 1.5 mm x 1.5 mm) SQ Notch

Flooring (porous substrate): Carpet Backings: (Non-Woven, Closed Cell & Enhancer) Coverage: 65-75 ft²/per gallon (6-6.9 m²/per 3.78 L)

* NOTE: The trowel notches referenced are those typically recommended for the type of flooring being installed, and are referenced as a guide. Coverage rates will vary depending on trowel type, substrate and installation conditions. Consult flooring manufacturer for their specific trowel recommendations.

3. INSTRUCTIONS

Limitations

- · For interior installations only
- Do not use this adhesive for pure vinyl or vinyl-backed products

Preparation

Subfloors must be structurally sound, dry, smooth, at (\leq 3/16" within 10'), level and free of excess moisture/alkali and all contaminants (oil, debris, paint, sealers, adhesive residue, etc.) that may inhibit the bond of the adhesive or the performance of the flooring and its installation. All substrate cracks, chips, holes, joints, high spots and irregularities must be adequately repaired. Patching compounds must be suitable for the use application, cement-based and polymer-modified, and applied according to the manufacturer's instructions.

Installation

Large temperature or humidity increases or decreases can affect the flooring and performance of the installation. Lift a corner periodically to ensure 100% coverage of adhesive to the flooring backing and the substrate to ensure a void-free bond.

Spread adhesive uniformly. Adhesive ridges should be of sufficient height to achieve full coverage of the substrate and the deepest recesses in the back of the flooring material.

Place flooring into the adhesive while the adhesive is still fresh. The amount of time in which you have to place the flooring will vary with temperature and humidity.

Clean-up

Fresh adhesive - warm, soapy water on a clean cloth.

 $\it Dried\ adhesive-$ use mineral spirits sparingly with a clean, white cotton cloth. DO NOT POUR DIRECTLY ONTO FLOORING.
