# 3. INSTRUCTIONS

## Limitations

- For interior installations only
- Do not use with vinyl products

#### Preparation

Ensure tongue and groove are clean, dry and free of any loose particles or contaminants. Ensure boards are flat and meet manufacturer's tolerance for installation.

#### Installation

Apply a bead of adhesive along the length of the tongue or groove according to flooring manufacturer's (bead size and application) guidelines. Insert tongue into groove and tap (as required) to ensure full contact. Assemble planks before glue skins over. Remove excess glue during the installation. Do not allow ROBERTS 1406 to dry onto the finish. Wipe seam with a lightly damp cloth. Keep cloth clean to avoid smearing glue. After installation, restrict traffic flow and moving heavy objects for 24-48 hours to allow adhesive to cure. Premature traffic and moving of heavy furniture can result in installation deficiency and / or failure.

#### Clean-up

Immediately remove fresh adhesive with water-dampened cloth. Dried adhesive will be difficult to remove.
