Recommended Trowel and Coverage Rate*



1/8" x 1/8" x 1/16" (3 mm x 3 mm x 1.5 mm) V Notch Flooring: Carpet (Woven & Polypropylene) Coverage: 90-110 ft²/per gallon (8.3-10.2 m²/per 3.78 L)

1/16" x 1/16" x 3/32" (1.5 mm x 1.5 mm x 2.3 mm) U Notch Flooring (porous substrate): Felt-Backed Sheet Vinyl Coverage: 160-180 ft²/per gallon (14.8-16.7 m²/per 3.78 L)

1/16" x 1/16" x 1/16" (1.5 mm x 1.5 mm x 1.5 mm) SQ Notch Flooring (porous substrate): Non-Woven, Closed Cell & Enhancer Coverage: 65-75 ft²/per gallon (6-6.9 m²/per 3.78 L)

* NOTE: The trowel notches referenced are those typically recommended for the type of flooring being installed, and are referenced as a guide. Coverage rates will vary depending on trowel type, substrate and installation conditions. Consult flooring manufacturer for their specific trowel recommendations.

3. INSTRUCTIONS

Limitations

- Do not use this adhesive for pure vinyl or vinyl-backed product
- Ensure adequate ventilation during flooring installation
- Not recommended for cork that will be installed as the final flooring surface
- Not recommended for cork underlayment when used for wood flooring installations
- When installing wood flooring, use ROBERTS® 1487 to adhere cork underlayment to substrate

Preparation

Subfloors must be structurally sound, dry, smooth, flat (<3/16" within 10'), level and free of excess moisture/alkali and all contaminants (oil, debris, paint, sealers, adhesive residue, etc.) that may inhibit the bond of the adhesive or the performance of the flooring and its installation. All substrate cracks, chips, holes, joints, high spots and irregularities must be adequately repaired. Patching compounds must be suitable for the use application, cement-based and polymer-modified, and applied according to the manufacturer's instructions.

Installation

This product is ready to use and does not require mixing. Materials and area temperature must be between $65-95^\circ$ F with a maximum RH of 65% for 48 hours before and during installation as well as for 72 hours afterward. Large temperature or humidity increases or decreases can affect the flooring and performance of the installation. Lift a corner periodically to ensure 100% coverage of adhesive to the flooring backing and the substrate to ensure a void free bond. Spread adhesive uniformly. Adhesive ridges should be of sufficient height to achieve full coverage of the substrate and the deepest recesses in the back of the flooring material. Place flooring into the adhesive while the adhesive is still fresh.

Clean-up

Fresh adhesive – warm, soapy water on a clean cloth.

Dried adhesive – use mineral spirits sparingly with a clean, white cotton cloth. DO NOT POUR DIRECTLY ONTO FLOORING.
